

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.creditcrisisclinic.com and Credit Crisis Clinic LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Credit Crisis Clinic LLC include www.creditcrisisclinic.com. The Credit Crisis Clinic LLC website is a Credit Repair Service site. By using the Credit Crisis Clinic LLC website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Credit Crisis Clinic LLC may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase Credit Crisis Clinic LLC's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

Credit Crisis Clinic LLC may also collect anonymous demographic information, which is not unique to you, such as your:
